# **Privacy Policy**

The purpose of this Privacy Policy is to describe how ArriTech ("We") collects, uses and shares information about you through our site. We are committed to protecting and respecting your privacy.

This Privacy Policy (together with any other documents referred to in it) sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

### Information We May Collect from You

We may collect and process the following data about you:

- If you contact us through our site www.arritech.com we may collect your name, country, company, e-mail, phone and a record of such correspondence.
- Details of your visits to our site including, but not limited to, traffic data, location data, weblogs and other communication data (see below the Google Analytics).
- If you participate in an online survey or questionnaire, any information you provide will also be maintained, but we will anonymize such data immediately.

# Our Legal Bases

We collect your data on the bases of legitimate interest in case you send us any message, so we are able to deal with it properly.

If we have intention to provide you any news or other information, we will ask you for your consent for this purpose.

### Where We Store Your Personal Data

The data that we collect from you are always stored only within the European Economic Area ("EEA") and we never transfer them outside the EEA. We always take all steps reasonably necessary to ensure that your data is treated securely and in accordance with the GDPR.

Where we have given you (or where you have chosen) a password which enables you to access certain parts of our site, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.

Unfortunately, the transmission of information via the internet is not completely secure. Although we take protection of your personal data very seriously, we cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk. Once we have received your

information, we will use strict procedures and security features to try to prevent unauthorized access.

### Uses Made of the Information

We use information held about you in the following ways:

- To be able to answer any of your messages raised through our site or via e-mail
- To ensure that content from our site is presented in the most effective manner for you and for your computer.
- To provide you with information, products or services that you request from us or which we feel may interest you, but in this case only where you have consented to be contacted for such purposes.

### Third Party Disclosure

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include website hosting partners and other parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others' rights, property, or safety.

None of the personal data are stored for more than 14 months unless we need them to protect our legal interests, or they are processed on the bases of your still valid consent.

# Your Rights

### **Cookies Policy**

### What are Cookies?

A cookie is a small text file that a website stores on your computer or mobile device when you visit the site.

- · First party cookies
- Persistent cookies

When you visit ArriTech website, you will be prompted to accept or decline cookies.

The purpose is to enable the site to remember your preferences (such as username, language, etc.) for a certain period of time.

That way, you don't have to re-enter them when browsing around the site during the same visit.

Cookies can also be used to establish anonymized statistics about the browsing experience on our sites.

### How Do We Use Cookies?

ArriTech's website mostly uses "first-party cookies". These are cookies set and controlled by us, not by any external organization.

#### The **types of first-party cookie** we use are to:

- · store visitor preferences
- gather analytics data (about user behaviour)
- make our websites operational

#### Visitor preferences

These are set by us and only we can read them. They remember:

- if you have accepted (or declined) this site's cookies in the cookie bar
- your language preference

### Analytics cookies

ArriTech uses cookies stored on the user's computer for the purpose of analyzing website visits and helping to improve their functionality. This information is used to provide information about website usage, such as which pages within the site are viewed and how often. There, no personal information about users is stored. ArriTech may also uses Google Analytics from Google. Analytics anonymously collects information and reports on site development without reporting individual users or personal information. Most browser settings can be changed to prevent cookies from being received. You can also delete cookies easily.

### **Blocking cookies**
